### Temporary road closure of L-5003-44 Blacklion Road, County Meath

Meath County Council has made an order to temporarily close the L-5003-44 Blacklion Road from its junction with the L-5007-0 to its junction with the R-155-0 to public traffic from **midnight on Sunday, 11 September 2022 until midnight on Friday, 30 September 2022** in order to facilitate the installation of ESB ducting as part of the grid route from the new solar farm at Hilltown towards the ESB substation located at Buntrasna off the R155-0.

#### Alternative Routes

##### Local Diversion

At the junction L-5007-0/L-5003-44 turn left and travel along the L-5007-0 for 1.2km. Turn left at the junction with the L50072-0 and continue until you reach the L-5003-44.

##### Main Diversion

#### - All vehicular traffic intending to travel southbound

At the junction L-5007-0/L-5003-44 turn right and travel east until you reach the N2. Turn right and travel south for 1.5km on the N2 until you reach Primatetown Junction (N2/R155-0). Turn right onto the R-155-0 and continue west until you reach the roundabout/junction of R155-0/L5033-44.

#### - All vehicular traffic intending to travel northbound

At the junction of R-155-2/L5003-44 turn right at the roundabout and travel north east to the junction with the N2. Turn left onto the N2 and continue north for 1.5km until you reach the junction with L-5038-0. Turn left onto L-5038-0 and continue west for 950m past the Snailbox Restaurant & Bar until you reach junction with L-5003-44.

### Planning Notice – Part 8 Proposed development in Loganstown, Newtown, Littlerath, Kiltoome and Peterstown in Trim, County Meath

In accordance with the above regulations, Meath County Council proposes to carry out development in the townland of Loganstown, Newtown, Littlerath, Kiltoome and Peterstown, Trim, Co Meath.

The proposed development will consist of the provision of a **Burial Ground with associated works** including:

- A total of 2,400 single burial plot Burial Ground, Garden of Remembrance and Columbarium Walls for the Interment of Urns;
- Internal Access Roads and footpaths to accommodate vehicular access and walking access Isles;
- An access road with a general cross-section of 12 meters incorporating a 2-metre grass verge, a 2-metre footpath with low level public lighting;
- A new entrance from the local road L-80171 (Loganstown/Rathnally Road) with gates and railings;
- Utilisation of the existing agricultural entrance with the construction of a new access road to east of the proposed Burial Ground to access the rear agricultural lands;
- A carpark with a total of 101 car-parking spaces with public lighting;
- A caretaker's office/canteen and toilet facilities;
- A waste-water treatment plant and percolation area;
- All associated works including boundary fencing, landscaping, surface water drainage and attenuation

- system, ducting, piping and ancillary works; and
- The upgrade of local road L-80171 incorporating a 2-metre-wide footpath with public lighting, road widening and drainage for a distance of approximately 600 metres from the Burial Ground entrance to the junction of the Navan-Trim R161 Regional Road.

In accordance with Article 81 of the Planning and Development Regulations 2001-2022, Meath County Council has concluded from a preliminary examination, that there is no real likelihood of significant effects on the environment arising from the proposed development and that an Environmental Impact Assessment is not required.

Any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effects on the environment.

### Planning Notice – Part 8 Notice of proposed development Navan Cycle Scheme – R147 Martha's Bridge to Circular Road Scheme

In accordance with the above regulations, Meath County Council proposes to carry out development works on the following roads and junctions in Navan:

- R147 Dublin Road, from its junction with the R161 Circular Road to its junction with L-34141 Swan Lane.
- The junctions of the R147 Dublin Road with the R-161-4 Circular Road, the L-3418 Academy Street and the L-5055-1, Bóthar Sion.
- L-34141 Swan Lane, from its junction with the R147 to its junction with L-34144-0 Klicam Court.

The proposed works will be carried out within existing roadway boundaries, with some minor relocation/setting back of some private boundaries.

**Construction works along the route will involve the following elements:**

- Construction of new kerb lines for new footpaths and cycle lanes/tracks;
- Provision of new footpaths and/or upgrading of existing surfaces on footpaths;
- Provision of controlled crossings points for pedestrians and cyclists;
- Provision of segregated cycling facilities;

- Provision for shared road space for cycling;
- Signalling of the existing R147/Academy Street Junction;
- Upgrading of existing signalised junctions;
- Removal of the existing right-turn-lane to the Riverside Filling Station;
- The provision of additional open space at the junction of R147 with Academy Street including additional landscaping such as tree, shrubbery etc.;
- Earthworks/excavations of existing roadways and verges, of existing roadway/footpaths, for service ducts and road crossings etc.; and
- All associated civil works with the above i.e. ducting, drainage, concreting, macadam works, tree felling, hedge removal etc.

The proposed works above will take place in the Townlands of Limekilnhill, Dillonland, Townparks and Balreask Old in Navan, Co Meath.

In accordance with Article 81(2)(ca) of the Planning and Development Regulations 2001- 2022, Meath County Council has concluded from a screening determination under Article 120(1B)(b)(i) that there is no real likelihood of significant effects on the environment arising from the proposed development and that an Environmental Impact Assessment is not required. Any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effects on the environment.

### Proposed temporary road closure of R165 Drumgill, Kingscourt, County Meath

Meath County Council intends to temporarily close the R-165 Drumgill, Kingscourt, Co Meath to public traffic in order to facilitate permanent reinstatement works to the public road surface from **Monday, 3 October at 8am until Friday, 7 October at 6pm**.

#### Alternative Routes

All traffic will be diverted onto alternative routes. Kingscourt bound traffic will be diverted via the N52/R162 from Mandistown Cross and vice versa. All diversions will be signposted.
