# Temporary Closure of Road L-5003-44 between Kilbrew and Irishtown, County Meath

Notice is hereby given that Meath County Council has made an order to temporarily close the L-5003-44 in Kilbrew, Ballyhack, Irishtown and Yellowshar, Co Meath between its junction with the R155-1 and its junction with the L-5007-0 and L-5007-15.

This closure is required to facilitate the installation of a 500mm watermain for Uisce Éireann to the Windmill Hill Reservoir.

The closure will commence at midnight Sunday, 1 October 2023 until midnight on Sunday, 29 October 2023.

#### **Alternative Route**

Diversion signs will be in place. Local access will be provided to residents and property owners.

# Proposed construction of new Town Centre Parking at Enfield, County Meath

In accordance with the above regulations, Meath County Council proposes to construct a new Town Centre Parking at Enfield, Co Meath. The Development will consist of:

- town centre car parking for access to local businesses;
  - parking for the playground;
- re-located parking for the Enfield Community Hub;
- parking for access to public transport links;
- car charging facilities;
- bicycle parking;
- electric bicycle charging facilities;

- re-location of recycling facilities for safer access;
- outdoor public plaza (approx. 1,200m²) to the front and rear of the Enfield Community Hub;
- CCTV to cover the facility; and
- associated site development works.

The Development has been subject to an Appropriate Assessment Screening in accordance with Article 6(3) of the EU Habitats Directive (Directive 92/43/EEC) and the Planning and Development Acts 2000-2022. In accordance with Article 81 of the Planning and Development Regulations 2001-2023, Meath County Council has concluded from a screening determination under Article 120(1)(b)(i) that there is no real likelihood of significant effects on the environment arising from the proposed development and that an Environmental Impact Assessment is not required.

Any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effects on the environment.
