## Planning Notice PART 8

Notice is hereby given in accordance with the regulations of the above, that Meath County Council proposes to undertake the following development in the Townland of Townparks, Athboy, County Meath. The proposed development will consist of:

- **A new Playground which is accessible to pedestrians via the existing entrances and footpaths along the Fair Green in Athboy.**
- **1.2m high safetop weldmesh fencing, galvanised and powder coated green, will be installed to the perimeter of the play area**
- **5 no small/semi mature trees to be relocated within the park – no mature trees to be removed**
- **All associated site works**

The Development has been subject to an Appropriate Assessment Screening in accordance with Article 6(3) of the EU Habitats Directive (Directive 92/43/EEC) and the Planning and Development Acts 2000-2022.

In accordance with Article 81 of the Planning and Development Regulations 2001-2024, Meath County Council has concluded from a preliminary examination under Article 120(1)(b)(i), that there is no real likelihood of significant effects on the environment arising from the proposed development and that an Environmental Impact Assessment is not required.

Any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effects on the environment.
